Subject: SAT Testing Update (09-22-20-02-A, -1, -2)

During the *Opening Schools in Recovery of Education–Update* discussion, Board members requested the following information:

Question A

Ms. Dixon requested the following:

1. Information concerning the number of students registered to take the SAT test at this time of year compared to previous years. Has staff observed a change in the number of registrations in light of the COVID-19 pandemic?

Response

Based on test-taker information provided by the College Board:

- On September 26, 2020, 1,088 Montgomery County Public Schools (MCPS) students took the SAT at 12 test centers in MCPS. Note that the September administration was a special test date offered by the College Board as a result of previous cancellations caused by the COVID-19 pandemic.
- On October 3, 2020, 1,647 MCPS students took the SAT at 14 test centers in MCPS schools.

By means of comparison, in October 2019, 409 MCPS students took the SAT in MCPS test centers.

The significant increase of SAT test takers in September and October 2020 is attributed to the SAT cancellations that occurred in March, April, May, June, and August 2020.

2. Demographic information of the 3,000 students registered to take the SAT test on Saturday, September 26, 2020. (The numbers of LatinX and African American students taking the test is of particular import.) Please take note of the MCPS students taking the test as opposed to the non-MCPS students who have registered at MCPS test sites.

Response

According to test-taker information provided by the College Board, demographic information of the MCPS test takers is included in the following charts.
