During Public Comments, Board members requested the following information:

### **Question B**

Ms. Harris requested a status update regarding the dashboard on the website regarding COVID-19 and its quarantine information.

## **Question B Response**

The COVID-19 Dashboard is updated weekly Wednesday morning to reflect the data from the prior week (Saturday – Friday). Based on feedback from the community and our county partners, the dashboard was revised and no longer removes cases and quarantines from the weekly count prior to the next update. Previously, cases and quarantine numbers would "drop off" after 10 days, causing confusion when the dashboard would reflect zero cases for a prior update. This has been modified and the data now remains a snapshot of the cases and quarantine numbers from the previous week. We continue to closely work with principals and the Office of Communications to ensure the data reflected on the dashboard are complete and accurate.

#### **Ouestion C**

Ms. Harris requested a status update regarding the hiring of the Health Officer. Also, what are the qualifications required for that position.

### **Question C Response**

The Medical/Health Officer position was advertised from November 17, to December 13, 2021. Applications will be reviewed in the coming weeks and interviews will be scheduled in January 2022. For your reference, the job description for the position is attached.

#### Description

#### SUMMARY DESCRIPTION:

The School System Medical Office (SSMO), under the direction of the superintendent of schools, leads the school system in matters related to the health of students, staff and families within Montgomery County Public Schools (MCPS). The SSMO is responsible for overseeing and facilitating proactive, preventative measures in safeguarding MCPS students' health and overall medical well-being of the MCPS community members and their families. The SSMO serves as the district's subject matter expert and advisor, particularly as it pertains to the COVID-19 pandemic, mental health and well-being, as well as other medical concerns that may arise. Works closely with Montgomery County Department of Health and Human Services (DHHS), community partners, medical professionals and other pertinent organizations to keep abreast of health metrics, trends, and concerns and quickly and effectively addresses medical issues through independent research, collaboration with community partners and swift execution of appropriate measures, including securing necessary medical supplies, funds, and other assistance, as needed. Develops policies and guidelines based on direction from national, state and local health officials. Assesses, identifies and reports the districts ongoing health needs, recommends strategies, and launches new initiatives to address the medical needs and health-related concerns that may arise and impact the MCPS community.
