SUBJECT: COVID-19 UPDATES—APRIL 2024

Summary

Starting April 15, 2024, Montgomery County Public Schools (MCPS) will align COVID-19 procedures with the new guidance from the Centers for Disease Control and Prevention (CDC), the Maryland Department of Health (MDH), and the Maryland State Department of Education (MSDE).

Background

- On March 1, 2024, the CDC released <u>new recommendations for common respiratory infections</u>, including influenza ("flu"), respiratory syncytial virus (RSV), and COVID-19. Notably, the new recommendations replace prior guidance for COVID-19.
- MDH and MSDE updated their school guidance on <u>March 15, 2024</u>, to align with the CDC updates for COVID-19 and other respiratory illnesses.
- Major changes to MCPS procedures include the following:
 - Students and MCPS staff will no longer need to follow the minimum 5-day isolation period for a new COVID-19 infection. Schools and worksites should transition to the new symptom-based strategy for any common respiratory virus, which recommends returning to work or school at least 24 hours after being fever-free with improving symptoms.
 - MCPS is still required to report school outbreaks to public health authorities. School and program administrators should continue to report possible COVID-19 outbreaks when there are multiple cases in a high-risk cohort per the Positive COVID-19 Case Quick Guide. MDH has changed the period of possibly related cases from 10 to 7 days.
 - Special leave procedures for absence due to COVID-19 are discontinued. Employees must apply for personal illness or illness in family leave for 5 days or more using MCPS Form 430-1 <u>Leave Request</u> and Form 440-35, <u>Certification of Physician or Health Care Provider</u>.
