16:49:41 Cassandra McGlorthan: Can you please repeat the number of classrooms. I think it is a total of 27 for Bent Bar. With 800 students that is about 30 kids a class, which is to many students.

**RESPONSE:** All the options are designed to the same program requirements. The options presented at the meeting included an additional 30 for the new building.

16:50:16 Judy Barth: We have 880 kids now.

**RESPONSE:** Based on feedback, the Educational Specifications have been adjusted from a 755 capacity to a 796 capacity. There will also be an add alternate for a four-classroom modular to accommodate the enrollment at South Lake Elementary School for the short-term. Consistent with MCPS Regulation FAA-RA, MCPS will continue to explore options to reassign students from South Lake Elementary School to another school with the Watkins Mill Cluster Capacity Study as a long-term solution.


16:51:01	Cassandra McGlorthan: Is the health room a health center?
	<b>REPONSE:</b> The school will have a Health Room and the School-based Health Center is under review with DHHS.
16:51:26	Jillian Storms: I am confused with the site plan for the Bent Bar Scheme. It appears to have the Student Drop off sharing the same access as the Bus Drop off. Wouldn't these be separate? (like having one be the loop around the staff parking)
	<b>RESPONSE:</b> Upcoming design updates will include separated student drop off and bus drop off loop.
16:51:40	Luci Bayles: My question as well is there a health center
	<b>REPONSE:</b> The school will have a Health Room and the School-based Health Center is under review with DHHS.
16:51:40	Judy Barth: I think the use of the hill and placement of the multipurpose room is a very nice proposal. The lower parking for concerts etc.
	<b>RESPONSE:</b> Acknowledged for future development of design.

	<b>RESPONSE:</b> 3-4 cots will be available.

	<b>RESPONSE:</b> Building layouts shall comply with required life safety code requirements. Life safety and building egress requirements will be further detailed as the design develops.
16:52:31	Emily Dematatis: How many square feet will the new health room be? A school population of our size should have at least 600 sq. ft.
	<b>RESPONSE:</b> Currently 710 sq ft will be provided if a school-based health center is not provided.
16:52:50	Emily Dematatis: In the old wing, the art room is extremely small, and we also have 2 art teachers.
	<b>RESPONSE:</b> The design will explore options to relocate the art room and reuse the current the art room for a different use.
16:53:01	Samim Sediqi: Please don't limit classrooms and capacity to anything less than 1000 students.
	<b>REPONSE:</b> Current guidelines are based on a core capacity of roughly 740 students for elementary schools. Based on feedback the Educational Specifications have been adjusted from a 755 capacity to a 796 capacity. There will also be an add alternate for a four-classroom modular to accommodate the enrollment at South Lake Elementary School for the short-term. Consistent with MCPS Regulation FAA-RA, MCPS will continue to explore options to reassign students from South Lake Elementary School to another school with the Watkins Mill Cluster Capacity Study as a long-term solution.

	<b>RESPONSE:</b> Yes, a retaining wall is needed to meet grades however, we will continue to evaluate the existing site conditions and look for opportunities to limit new site structures.

	<b>RESPONSE</b> : Students will congregate and enter the building through a main entrance area. Options for approach and entry from vehicular drop-off are being explored for each scheme.
16:53:46	Elysia Avila-Miller: spaces to consider: staff lounge, staff workspace, arts, music, special ed? how are those spaces included in the plan?
	<b>RESPONSE</b> : The Schemes presented are at a concept level and do not show all required program spaces. Locations will be shown as the design develops further.
16:53:47	Emily Dematatis: I agree with Samim, it does not make sense to create a new building that does not fit our current population.
	<b>RESPONSE:</b> Acknowledged. Capacity increased as identified in other responses.
16:54:38	CROSSDEN: the gym does not relate very well to the fields. seems like this should be solved for a new school. could the existing gym be repurposed, and a new gym flipped to the field side?
	<b>RESPONSE:</b> This scenario is explored under Scheme C. Repurposing and replacement of existing gym is under evaluation.
16:55:38	Adoree Betancourt: we have a lot of students almost 900 how will this plan help? seems to me we will still have the same issue of not enough space.
	<b>RESPONSE:</b> Capacity increased as identified above in other responses.

	<b>RESPONSE</b> : Options for approach and entry from vehicular drop-off and bus loop are being explored for each scheme.

	<b>RESPONSE:</b> A new HVAC design is being provided.
16:56:03	Maria Romero: I'm confused. Media center will be in the lower level?
	<b>RESPONSE:</b> This Scheme proposes the Media Center and Multipurpose Room at the lower level where these spaces would be adjacent to outdoor space and provide opportunities for community access.

	<b>RESPONSE</b> : Bus and student drop-off loops will be separated to help with the flow of traffic.

	<b>RESPONSE:</b> Sloped courtyard will be further evaluated as design develops.

	<b>RESPONSE</b> : This option will be explored and subject to further evaluation.

**RESPONSE:** Use and function of courtyard shall be further defined.

**RESPONSE**: Yes. Drainage would be provided at the lower level termination to capture anticipated rainwater.


17:05:14 Samim Sediqi: what safety and security measures are thought of? parameter fence? we don't want intruders to get in the courtyard easily!

	<b>RESPONSE</b> : Egress access will be reviewed and designed to meet Code.

	<b>RESPONSE:</b> In this Scheme, a more compact footprint is proposed, and the courtyard provides opportunity to introduce daylight into the building, as well as opportunities for outdoor activities.

	<b>RESPONSE:</b> At the Lower Level adjacent to the fields.
17:10:42	Cassandra McGlorthan: Will there be a door in the multi-purpose room so students can go right out to the play field for recess
	<b>RESPONSE</b> : Where proposed to be at the lower level, the MPR could be provided with access to the fields. To be determined with MCPS and school staff.
17:10:53	Judy Barth: courtyards add light and can be a very useful space for outdoor learning
17:11:55	iPhone: I think that's always the idea, but they tend to be abandoned. A precedent study of MCPS schools (specifically elementary) with courtyards would be helpful.

	<b>RESPONSE</b> : Functions within the courtyard can be further explored for future development.

17:17:32 Cassandra McGlorthan: Can you explain a little more about the entrance from the library? Not sure that would be good if the library isn't open, so students don't wonder.

**RESPONSE**: The Media Center has a dedicated entrance on Level 02.

- 17:17:45 CROSSDEN: should it be the pavilion scheme?
- 17:17:50 Jillian Storms: This scheme does not seem ADA accessible in the use of courtyard and site drop off

**RESPONSE:** ADA accessibility is a priority and will be provided throughout the site.

17:17:54 Brian Franco: I like this option because it solves the bus drop off, staff parking, and student drop off

**RESPONSE**: Further development is needed as the student and bus drop-offs will require further separation.

17:17:57 Cassandra McGlorthan: I like the gym and multi-purpose room being located near the field.

**RESPONSE**: Further evaluation is needed to confirm this approach.

**RESPONSE:** Three story schools are designed in MCPS elementary school. As answered previously, the design will be based on a 796-student capacity with an alternate for a fourclassroom modular to accommodate the enrollment at South Lake Elementary School for the short-term. Consistent with MCPS Regulation FAA-RA, MCPS will continue to explore options to reassign students from South Lake Elementary School to another school with the Watkins Mill Cluster Capacity Study as a long-term solution.

17:18:32 Judy Barth: Is the Academic Area on this perspective--- 3 stories? The front left of the building 2 stories? Looks like they are not connected on the top floor?

**RESPONSE:** Academic portion is 2 levels.

17:18:48 Cassandra McGlorthan: Can you talk a little more about the garden space?

**RESPONSE**: The Garden activates the space formed by the folded-bar layout and also connects to the outdoor field area. Use of Garden can be further explored if this Scheme is selected.

**RESPONSE:** Walkers will be kept in mind during the design.

- 17:21:31 Cassandra McGlorthan: Is there a way to include a design to support more students. It wouldn't make sense to build something that doesn't meet the current needs of the school. The needs will continue to increase with new development in the area.

**RESPONSE**: These are Conceptual level schemes and will be developed further to address MCPS and school community feedback.
