#### **RESTORED HOPE AND CONFIDENCE**

When and why do we sometimes find it necessary to pour out our hearts and souls to someone? Is it mainly during times of crisis when we're looking for someone to share our pain or to help lift a heavy burden, we're dealing with in our life? Is it to vent frustration, to scream at the top of our lungs, "Doesn't anybody care?! PLEASE, someone help me!" Or could it be that pouring out one's heart is the only way left to get people to listen and be inspired to do something? I guess I am guilty of all of these.

As I reflect on my "THIS COULD BE THE LAST YEAR OF OUR TOOLKITS PROJECT! DON'T LET IT HAPPEN!!" article in the February newsletter, pouring out my heart and soul didn't turn out to be such a bad thing! I really needed to hear from MCPSRA members that there are others out there who care, who really understand just how important our project has been over the years to the neediest of our county's school children and their families, and who realize how devastating it would be to have to do away with it at this time when it is needed more than ever. My plea did not fall on deaf ears. Immediately after our February Newsletter came out, responses starting pouring in from members near and far. Many donations were accompanied by a brief note: "SO sorry to hear that you've worked SO hard and so few people are supporting this project. I've doubled my contribution - may others do the same!" "Thank you for your hard work and efforts!" "PLEASE try to keep this project going!!" "This is a GREAT project - thanks for being so faithful to it." With each kind note and each donation, my hope was restored and my confidence that we can keep this project alive soared.

When the February newsletter went to print, we had only received 74 donations for a total of \$5,660. With the estimated cost for this summer's project at \$29,000 to \$30,000, the task of raising enough money to continue planning for our project in four to five months seemed an impossibility. It is with enormous gratitude and tears of joy to be able to report that at present we have received 191 donations for a total of \$17,190! That is truly remarkable - such an outpouring of caring, commitment, and generosity from MCPSRA members who actually heard my plea and responded so quickly. I think I can almost see the light at the end of the tunnel, as the old saying goes.

We have a long way to go, though, to be able to fully fund this summer's project of providing 2,200 toolkits to needy kindergartners and Head Start students who will be participating in the Title I Extended Learning Opportunities Summer Adventures In Learning (ELO SAIL) Program at approximately 26 school sites in July and August. PLEASE step forward and join those who have already contributed to guarantee that our project will be successful again this summer. ## MCPSRA Budget for Next Year (2020-2021)

#### Steve Raucher, Budget Chair

The proposed budget for MCPSRA for Fiscal Year 2021 [July 1 2020 – June 30 2021] is included in this newsletter. It includes funding for the scholarships we give annually, support for our Toolkits Project, support for the Josiah Henson

Park project and covers the continuing costs of operating our association. To fund all these activities will require \$32,925.

Unfortunately, our membership numbers have not kept pace with our financial needs. Therefore, the budget had to increase our individual <u>annual</u> dues by \$5 [from \$10 to \$15] starting this coming July. We simply can't continue to represent you and provide the support to our scholarships and projects with the current dues income.

To put this in perspective, we have not had a dues increase in over 20 years. The U.S. Bureau of Statistics shows that the median US salary in 1999 was \$42,000 and increased to \$65,191 by 2020 JUST DUE TO INFLATION that's a greater percentage increase for 20 years than our dues increase.

We surveyed all the other local counties and found that most have already increased their dues. All of the other large counties are charging \$15 already.

I hope you will support this budget which will be presented for membership approval at the April 23, Luncheon Meeting.

The Maryland Primary Election is Tuesday, April 28, 2020, and the MCPSRA Political Action Committee (MCPSRA-PAC) has been hard at work. Their goal was to identify the candidates for Montgomery County Board of Education and U.S. Congress (Districts 3, 6, and 8) who best support the interests of MCPSRA members.

All candidates who filed with the Board of Elections for seats on the Montgomery County Board of Education in District 2 or District 4 or At Large, or for the US House of Representatives in District 3, 6, or 8, were contacted and offered the opportunity to participate in our process.

All candidates who were reached were sent a questionnaire prepared by the PAC and a biographical form to complete. Those who responded were offered an interview with the Committee. The PAC held interviews during the first two weeks in February.

## **MCPSRA Recommended Candidates for the MCPS School Board**

#### Sunil Dasgupta - Candidate At Large

Why are you running for this office?

Education does not arrive magically to our students. We face unprecedented challenges with teacher retention and balancing resource allocation. I want to hire more teachers and staff, reduce class size, rebuild the home/school partnership, and invest in the health, safety, and wellness. Where is the money? We have to make sure the state and county will fully fund schools, and I hope to rebalance capital and operating budgets to stretch the money we have.



What qualities or experience do you have to serve on the school board? I am a firstgeneration immigrant and parent of 3 MCPS students. I have 20 years of classroom teaching and policy research experience, 11 teaching MCPS graduates. I have worked with budgets, financial reports, and data. I have been a PTA leader and founded the annual Mental Health and Wellness Forum for students, staff, and families. I have served on various school-related MCPS and county committees including on health, safety, use of screens, and the Planning Board's Subdivision Staging Policy and I have written publicly on education issues and testified before the Board of Education, County Council, and other forums.

# What is the most important issue in this race and what specific plans do you have to address it?

While school boundaries may be the runaway issue, our focus should absolutely be on closing the performance gap while enabling students who are doing well to do even better. There is no one silver bullet, but hiring more staff is step one toward reducing staff ratios; retaining and training teachers better; improving rigor and content in the curriculum; targeting resources to those who need it most; rebuilding the home and school partnership; and enabling investments in health, safety, and wellness. To do all of this, we need a strong BOE to secure resources, reprioritize, and rebalance capital and operating budgets.

#### Shebra Evans - Candidate District 4

My name is Shebra L Evans and I am running for re-election for the Montgomery County Board of Education, District 4 seat. I cannot thank the Montgomery County Public School Retirees Association enough for your endorsement in my bid for re-election and for your continued support in my current role as board president. I am happy to share some of what has been accomplished during my time on the board. We have redoubled our commitment to expanding access and opportunity so that all students have what they



need to be college, career and community ready. System wide, this looks like universal screening for enriched and accelerated programming at the middle and elementary school level. Many students who needed the enrichment and acceleration did not have the knowledge, time, or resources to support the application process were excluded from the program. Our All In: Equity and Achievement Framework looks at individual student progress through the Equity Accountability Model; and how resources (people, time and money) are allocated and used at schools through the Equitable Access to Resources study. We have unmasked disparities in outcomes by disaggregating student performance by race, poverty, and the intersection of race and poverty at each school. Our continued work looks like expanded access to prekindergarten. MCPS has added hundreds of full day pre-K seats for the last several years and will continue to work with the County to expand early education. We support the Blueprint for Maryland because the legislation will provide significant funding to public schools in Montgomery County and across the state. In particular, it will increase support for early education - a primary focus for our school system. I believe that an empowered and informed community is the most effective way to build a high-quality school system. This has been the foundation of my work these past four years. I will continuously strive to foster a productive partnership with the school system and the community we serve.

# **MCPSRA** is Working for You

On March 5, two members of the MCPSRA Board of Directors went to Annapolis to represent you. They met with Senators and Delegates to lobby in favor of four bills currently under consideration. Your representatives at the Maryland Retired School Personnel Association (MRSPA) Lobby Day were Fred Evans and Russ Wright. Fred met with Senator Cheryl Kagan and Delegate Julie Palakovich Carr. Russ met with Senators Jim Rosapepe and Pamela Beidel and Delegates Mike Rogers and Mark Chang.

Here are the bills Fred and Russ lobbied in favor of:

### HB 1300/SB 1000 Blueprint for Maryland's Future – Implementation

The Blueprint for Maryland's Future is the bill to increase education funding in the state with the goal of greatly improving our schools. Although we spoke in support of the goals of these bills, we cautioned Senators and Delegates about several of our concerns:

- the legislature must avoid any cuts to retiree benefits in their search for the funds needed.
- the legislature must avoid tax increases that will impact retirees, especially retirees on fixed incomes.
- the legislature must keep in mind that some retired support staff receive little or no pension left after their monthly health insurance premiums are deducted.

# HB 745/SB 407 Office of the Attorney General – Senior and Vulnerable Adult Asset Recovery Unit

This bill establishes a two-person unit within the Office of the Attorney General to bring civil actions to recover assets unjustly taken from seniors and other vulnerable adults by scammers and other criminals.

### HB 1095/SB 669 Prescription Drug Affordability Board and Fund

The Prescription Drug Affordability Board will work to reduce prescription costs for all Marylanders.

### HB 1365/SB 786 Income Tax Credit for Long Term Care Insurance Premiums

This bill will provide a small tax credit to encourage more Marylanders to purchase long-term care insurance.
