#### THE ROAD TO SUCCESS IS ALWAYS UNDER CONSTRUCTION

Another road under construction? One road isn't done before they're starting a new one. Our road to success has taken fourteen years. Will it ever end? "NO!"

During the past 14 years the MCPSRA **Toolkits**, **Books**, **and Backpacks Project**, has provided nearly 18,000 kits and 225 backpacks of school supplies as well as 8,900 new books to Title I ELO SAIL elementary summer school children. Over 2,000 toolkits were assembled this summer alone. We now begin year fifteen. and the need is growing.



We have met and conquered many obstacles over the years, the biggest has been raising the necessary funds to



continue with the project. But we truly believe that the road to success is always under construction and that *triumph* is just *umph* added to *try*. Someone once said, "If the going gets easy you may be going downhill." So we wish to express our sincere thanks to everyone who provided the *umph* that paved the road for this past summer's project: the 292 individuals, organizations, and businesses who sponsored toolkits with monetary donations totaling \$26,985 (especially John and Susan Vaszko, Drs. Lois and John Martin, the Sigma Chapter of Delta Kappa Gamma Society International, and the Kiwanis Club at Leisure World), the Educational Systems Federal Credit Union for its \$1,000 contribution and the rulers and pencils for the kits, the Germantown Target store for acquiring 2,000 shoe boxes for us at cost, the many individuals and school, church, and scout groups who collected over 110,000 bottle

caps used for math and sorting activities including the Eagle Ambassadors at Seneca Valley HS, the residents at Asbury Methodist Village in Gaithersburg, the Red Hatters of Merryland, and the very special group of Wootton HS students who spent months counting out and bagging the caps. A special thank you goes to Steve and Janet Silvious who took the time to place yellow happy face stickers on the many hundreds of bottle caps they donated. We were simply delighted when John Vaszko, a MCPSRA member and the author of two children's books, The Gift and A Day in the Garden, donated 50 autographed copies of each book that were awarded to kindergartners at the parent training sessions at each summer

school site. Enormous thanks go to MCPSRA members Diane Wells and Pam Grant who spent hundreds of hours at the MCPS Warehouse sorting and bagging bottle caps, labeling shoe boxes, collating lesson plans, stocking the assembly line, and assembling the toolkits. (Many individuals volunteered to help but due to a conflict with another group that was scheduled to



use the same space, we had to restrict the number of people who could work at one time at the warehouse.) Most importantly, our project would not be possible without Lanny Taylor and his crew at the MCPS Department of Materials Management. He provides space to assemble kits, orders items for the kits, and distributes the kits to schools. Finally, thanks to all the Title I specialists and Camiele Jones-Akinkuowo who coordinated this summer's project at 22 school sites and conducted parent seminars on how to use the items and lessons plans in the kits with their children at home.





As we plan for next summer's project and embark on a new fundraising campaign, please consider sponsoring toolkits with a generous tax-deductible contribution. You too can help pave the road to success for another group of eager little in-coming kindergartners who will start their educational careers next September. #### MCPSRA-JOSIAH HENSON PROJECT

he MCPSRA has resolved to help support the

establishment of a museum and education center at the Josiah Henson Park in North Bethesda.

Josiah Henson was a very famous resident of Montgomery County. He lived here from 1795 to 1830 as a slave on the Isaac Riley Plantation near the intersection of what is now Old Georgetown Road and Tilden Lane. The Park is located on a small part of the property where Josiah Henson lived.



In 1849 Henson became one of the most influential international figures of the 19th Century when his autobiography was published. It was entitled *The Life of Josiah Henson, Formerly a Slave, Now an Inhabitant of Canada, as Narrated by Himself.* Henson's autobiography inspired Harriet Beecher Stowe's landmark novel, *Uncle Tom's Cabin.* The most liberal abolitionists felt *Uncle Tom's Cabin* was not strong enough. More moderate abolitionists praised the book for putting a human face on slavery.

According to legend, in 1862 Abraham Lincoln greeted Harriet Beecher Stowe by saying "So you're the little woman who wrote the book that started this great war." Whether that story is true or not, the legend underscores the connection between *Uncle Tom's Cabin* and the Civil War.

In his autobiography, Henson vividly described his experiences living as an enslaved person on the Riley plantation. Although, many of these experiences are recreated in Stowe's famous novel, there are major differences too. Unlike the fictional "Uncle Tom" who was killed by the order of his owner (Simon Legree), Henson escaped to Canada where he established the Dawn Settlement for fugitive slaves (located near Detroit, between Lake Erie and Lake Huron). As a conductor on the Underground Railroad Henson led over 200 people from enslavement in the United States to freedom in Canada. Henson traveled to England three times to raise money for the Dawn Settlement, and on March 5, 1877, he was invited by Queen Victoria to meet with her at Windsor Castle.

In 1983, Josiah Henson became the first black person to be honored with his likeness on a Canadian postage stamp. Josiah Henson Park preserves the owner's house and a small part of the plantation property of Isaac Riley. The Josiah Henson Project is raising funds to construct a museum and educational facility to be located on the property where Henson was enslaved. The museum will portray Henson's life and the Maryland slave experience. It will also explore the impact of Stowe's novel.

## THE MONTGOMERY COUNTY STATE'S ATTORNEY'S OFFICE TRUANCY PREVENTION PROGRAM

The Truancy Prevention Program (TPP) is an initiative of the State's Attorney's office. It is an early intervention program with the mission to improve attendance of middle school children in Montgomery County Public schools by discovering the root causes of truancy and assisting students and their families with issues that impact attendance. The program confronts school absenteeism by addressing academic, school, personal, and family-related factors. The Truancy Prevention Program is a voluntary and supportive program designed to keep children in school and families out of court.

VOLUNTEER WITH US! Be a positive influence. Have a great conversation with children. Make a lifetime of difference. Enrich and empower community, society and self. One student, one family at a time. 7 out of 10 children in the program experience a 65% or better reduction in unexcused absence.

The Truancy Prevention Program is a rare opportunity to have a true and meaningful impact on children's lives. Collaborate with attorneys from the State's Attorney's Office, staff from the Montgomery County Public middle schools, school resource officers from the Montgomery County Police Department and other dedicated volunteers from our community.

Volunteer opportunities include tutors, mentors, facilitators, and site coordinators. Be a TPP volunteer.

#### IRS Scams Making the Rounds - and Tips to Avoid Becoming a Victim

MRSPA members have reported receiving calls supposedly from the IRS. The caller says the IRS is threatening a lawsuit or legal action against you and to call the number given immediately. The number from which the call originated may look like a local number.

#### What are some easy signs to look for that indicate a scam call?

Kyle Roder, a public information officer for the Police Department in Eau Clair, Wisconsin says that neither the IRS nor legitimate companies are going to cold call you and threaten you the way scammers do. The IRS is not going to call you at all. They're not going to elicit that fear from you. That's what all scams do, they playoff of some type of emotion, whether it's fear or another factor like the joy of winning a prize. If you're getting a call or you're getting an email that's "very urgent," be careful.

#### What should you do if you realize you're on a scam call?

The best way to react in any scam on the phone is to hang up, or not answer in the first place.

If it's online, avoid clicking into anything suspicious or pushing any buttons. The more you talk to somebody, you could be providing information without knowing it, no matter how savvy you think you might be. They could be recording your voice so they can use it against you to obtain personal information or financial information in the future.

Telephone numbers can be spoofed now to look like a local phone number. The safest bet is always, if you don't know the number or you didn't initiate the call, **don't answer it**. Let the caller leave a message.

You can report a spam caller right on the IRS website, the Federal Trade Commission's site and the Better Business Bureau's sites. Also notify your local police department.

#### Senior National Parks Lifetime Pass Rates Increased from \$10 to \$80 on August 28th.

As reported on the MRSPA website, the "America the Beautiful- the National Parks and Federal Recreational Lands Senior Pass" increased for the first time since 1994. You can obtain an annual Senior Pass for \$20 - valid for 1 year from issuance If you already have a Senior Pass, your benefits remain.

#### Things to buy in October and things to skip!

**Best buys in October:** Jeans, Camping Gear and Outdoor Supplies, Air Conditioning Units, Halloween costumes and candy (wait until the week before Halloween to get the best deals)

**Worst buys in October:** Television sets (if you missed the September deals, wait until Black Friday for better deals), Appliances (deals will be better in November).

#### **Savings on the Road:**

If your car is driven under 5,000 miles a year, ask your insurer for a low-mileage discount. Annual average savings: \$92.00.

**Buy gas on Monday.** It's the cheapest gas day in 23 states, according to GasBuddy. Thursday is the most expensive day. Stick to Mondays and save \$325 a year.

**Be a chill driver.** Hard braking and speeding can lower your gas mileage by 30 to 40 percent. At an annual gas consumption of 480 gallons, you could save \$460.

**Take a driving class.** Insurers can offer up to 15 percent off for older drivers who take an online safety course - that's up to \$675 over three years on a typical policy.

#### Get your house ready for Fall/Winter

Check for drafts. Feel for drafts around the edges of windows and doors. If necessary, replace seals and repair caulking around window and door frames. Consider buying heavier or insulated drapery for especially drafty windows.

**Have your furnace inspected.** Hire an HVAC professional to test for leaks, check heating efficiency, and change the filter. They can also do a carbon monoxide check to ensure air safety. It's also a good idea to stock up on extra air filters and change them every few months.

**Winterize your air conditioner.** If your home has central air conditioning it may be necessary to cover your outdoor unit for winter. If you use window air conditioning units, remove them or cover them to prevent air leaks.

**Programmable thermostat**. Buy a programmable thermostat. If you already have one, check the temperature settings. Setting your thermostat to lower the temperature automatically at night and when you're not home, can result in substantial savings.

**Test home safety devices.** Replace the batteries in all smoke detectors and carbon monoxide devices and test to make sure they're working.

**Clean humidifiers.** Replace old filters and clean inside compartment. Vinegar is inexpensive and works well.

MCPS has mailed to all retirees in the school systems insurance programs a card announcing that on January 1, 2018 CareFirst will replace Cigna as the medical plan for all those currently enrolled in the Cigna plan.

If you are currently insured by Cigna you have the option of doing nothing and thus being moved to the same plan type with CareFirst on January 1, 2018. If you prefer you can change by selecting from the following plans:

- \* CareFirst BlueChoice HMO
- \* Kaiser Permanente HMO
- \* CareFirst BlueChoice Advantage Indemnity/Medicare Supplemental Plan (fee for service plan)
- \* CareFirst BlueChoice Advantage (POS/PPO)

The card you will, or have already received, also announces that there will be opportunities to review your insurance benefits by attending information sessions at one of several Retiree Benefits Open Enrollment Fairs between October 9 and November 3, 2017.

In early October, MCPS will mail information about the dates and location of the Open Enrollment Fairs.

All retirees are urged to review your current plan and consider attending one of the Open Enrollment Fairs to ask any questions you have about your coverage. These fairs give you an opportunity to discuss your coverage with a representative from each of the four plans listed above.
